# **Recognition of Study Periods**

Study periods in the same degree course at another tertiary education institution within the jurisdiction of the *Grundgesetz* (Basic Law), must generally be accredited in full. <a href="Other-study">Other</a> study periods at tertiary education institutions must be accredited in full or in part, if the former degree course was <a href="equivalent">equivalent</a> and <a href="periods-study">beneficial</a> for the new degree course. For degree courses that end with university examinations, the examination board responsible will decide on the accreditation of previous study periods; for courses that end with state or church examinations, the decision will be made by the Examination Office responsible. Students are asked to request the corresponding Letters of Recognition in good time. They must be attached to this request form.

# Information on Applications to More Advanced Subject Semesters at the University of Greifswald

The request form must be fully completed and signed and include the required proof stipulated on the attached form and then submitted to the Students' Registration Office for a Winter Semester by the 31/08, and for a summer semester by the 28/02. The decisive date is not the date on the postmark, but the day on which it was received at the University. Applicants for study places with a foreign higher education entrance qualification must apply via uni-assist:

Requests that are incomplete or not submitted in the correct form will be excluded from the allocation procedure in subjects with admission restrictions. Missing documents that you do not have by the end of the application deadline, must be submitted, at the latest, 14 days after the end of the respective application deadline. Please submit all proof as simple copies. For application to or enrolment in a second or more advanced subject semester, your higher education entrance qualification must entitle you to study the degree course you are applying for in Mecklenburg-Vorpommern. You must either have already studied at least one semester in the same degree course or subject at another university in Germany or the EU (change of town, dropped out) or be able to provide proof of achievements from other degree courses or from countries outside of the EU which can be accredited (student changing degree course). For transfers from a university within Germany or the EU, previous subject semesters will be accredited in full if studies are being continued in exactly the same degree course. Students changing degree courses require a notice of transfer of credit from the examination board or examination office responsible, this also applies to credits acquired during periods of study at foreign universities. Details about the organisation of the course, subject combinations and examination and study regulations are available from the subject advisors responsible within the departments and the Office of Academic Counselling and Course Enquiries. Application documents will not be returned. Therefore, please do not submit any original documents. Reference to documents you may have already submitted is not allowed.

#### **Admission Procedure**

In most degree courses, which have admission restrictions for the 1<sup>st</sup> subject semester, study places will only be allocated for more advanced subject semesters, if study places become available due to students changing towns or dropping out. Admissions will only be granted, if **all requirements** for starting a degree in the relevant subject semester have been met. Which degree courses and subject semesters are actually affected, depends on the admission numbers set by the ministry responsible.

Applications to subject semesters that exceed the normal length of study are not possible. In degree courses in which university entrants are only able to start in the winter semester, admission may only be granted to uneven subject semesters for winter semesters and to even subject semesters for summer semesters. Applicants who do not correspond with this rhythm must generally be rejected.

The selection is made in accordance with the statutes on the allocation process for study places in more advanced subject semesters for degree courses with admission restrictions in the following order:

- 1. Applicants who have or had confirmed enrolment in the same degree course at a university within the jurisdiction of the Interstate Agreement or at a university in one of the member states of the European Union (transfer applicants/returning students)
- 2. Other applicants who can prove that the required study achievements and study periods will be accredited for the subject semester in the degree course they are applying for (students changing degree courses).

If a selection has to be made within the two groups of applicants, the ranking will be determined by the special regulations for the respective degree course, as stipulated in the statutes (*Satzung der Universität Greifswald für das Vergabeverfahren von Studienplätzen in höheren Fachsemestern bei Studiengängen mit Zulassungsbeschränkung* (Statutes of the University of Greifswald for the Allocation Procedure of Study Places in More Advanced Subject Semesters for Degree Courses With Admission Restrictions) of 29<sup>th</sup> July 2008 in the respective valid version).

You can expect to receive notification for summer semesters from the end of March and for winter semesters from the end of September onwards. Predictions regarding chances of admission for degree courses with admission restrictions cannot be made, we therefore ask you to refrain from making any further inquiries. If you receive admission in a possible clearing procedure, you will be informed straight away, please therefore remain available via post or email.

Pursuant to § 15.1 of the *Immatrikulationsordnung* (Enrolment Regulations) of the University of Greifswald, a confirmation of acceptance for studies becomes ineffective, if the study place has not been accepted or enrolment has not taken place within the deadline set in the Confirmation of Acceptance for Studies. More details can be found on the Confirmation of Acceptance for Studies.

Due to the allocation of clinical placements, applicants for degree courses in Medicine, Dentistry and Pharmacy must register with the respective subject areas immediately after enrolment.
